This year the host city will be Los Banos, which holds its May Day Merced County Fair Parade Saturday, May 1st. The Chair will be Kassie Gutierrez. The friendly community is seven miles east of the Interstate 5 freeway, and will be very parader-friendly. Kassie will be sending you parade packets this month and all paraders are invited to participate in either the Championship or local portions of the event. The awards banquet and adjacent County Fairgrounds will offer fun activities for all ages.

I hope to see many of you at the newly sanctioned CSHA event, the Backcountry Horsemen Rendezvous, to be held in Merced, March 20th.
