Trails, Sharon Wagner - The city of Norco is putting together a trail guide, similar to the hiking and path maps put out by other recreational agencies, to incl. mileage, difficulty and connecting loops. John Vint is working on a new trail loop from the Van Buren bridge to Martha Mc Lean Park and Anza Narrows to Jurupa. The Ponds at Hidden Valley are dry due to management and equipment changes at the sanitation plant. New equipment was installed to filter the waste water thus eliminating the need to release the water to Hidden Valley for percolation. There is a contract with the water district for water to the ponds, however the District remains unwilling to release and the contract has been called into question.

OLD BUSINESS – The donated ETP/CSHA TT fencing was delivered to John Vint by Ron Watson. The fencing was purchased at half price from Whitecap Supply, and is earmarked for trail fencing along Arlington Ave.
